### CONDITIONS FOR ACCEPTANCE OF THIS APPLICATION:

- ✓ All tags from seed sown must be supplied to BVAQ when submitting applications.
- ✓ Grower agrees to abide by the terms and conditions of the relevant certification scheme.
- ✓ The grower understands that crop registration forms must be received by BVAQ by **June 30** or three weeks after the crop was sown.
- ✓ BVAQ will carry out inspections of crops registered unless written instruction is provided from the grower, Seed Company and/or Seed Agent to withdraw the crop from certification. Failure to provide adequate notice to BVAQ staff and inspectors will result in charges being applied.
- ✓ Late entries may be accepted at the discretion of BVAQ where a late entry fee will be applied.
- ✓ **\*All clover crops**, except White clover, must have 2 unsown strips of 1m x 100m on both sides of the paddock to determine paddock contamination levels. Unsown strips are required to satisfy certification rules.
